A Resolution Concerning the Continuity of Policies, the Member Welfare Group, and the Refunding of Partial Memberships

For the purposes of continuity with the membership policies and conduct of the previous organization, the CENTRAL COMMITTEE hereby makes the following commitments:

RESOLVED, that the “Policy Handbook” attached to this resolution shall be passed in its entirety, and shall be used in accordance with ARTICLE THREE: MEMBERSHIP when applying its text to membership conduct.

RESOLVED, the Member Welfare Group shall be formed as a committee under the authority of ARTICLE SIX: COMMITTEES, and shall be charged with maintaining the good conduct and decorum of the membership. The members of this committee are as listed below, referred to in the manner of which their identities are displayed on the Member Only Slack:

Laura Pedersen, Head of Committee.
James DeNiro, Member.

RESOLVED, the Member Welfare Group shall provide supervision of the activities of the membership and shall take all complaints of discrimination, harassment, any malicious action, or any suspicious activity and shall discuss this amongst themselves in a confidential manner. The Member Welfare Group shall vote on whether or not to refer the matter to the CENTRAL COMMITTEE for disciplinary review. The Head of Committee may, at their discretion, refer any matter to the CENTRAL COMMITTEE without a vote of the Member Welfare Group.

RESOLVED, any member of the Member Welfare Group may be appointed and removed by simple majority approval of the CENTRAL COMMITTEE.

RESOLVED, that any member who resigns their membership in the SOCIALIST RIFLE ASSOCIATION may request a partial refund of their annual dues. The Secretary may request any information necessary to process as a refund. If the member has a membership card in their possession, the Secretary may request the member mail their card to an address where the organization may collect said card.

RESOLVED, that any member who is involuntarily removed from the SOCIALIST RIFLE ASSOCIATION in accordance with ARTICLE THREE: MEMBERSHIP, shall surrender their membership card and mail their card to an address where the organization may collect said card. Receipt of this card shall be required prior to the issuance of any refund. The Committee may, at its discretion, override this provision by a two thirds majority vote.

RESOLVED, that it shall be the duty of the Treasurer and Secretary to determine the date dues were paid by the member in question, and to prorate the refund based on how many calendar months have elapsed. For partial months, the Secretary shall always round down to establish an integer divisor. Upon
