*A Resolution Concerning the Creation of Instructor Sponsorships and the Creation of Policies by the Officers*

The CENTRAL COMMITTEE of the SOCIALIST RIFLE ASSOCIATION INC., in its commitment as a not-for-profit corporation and a 501c4, sets forth the following for the creation of new policies for day to day operation of the organization and the creation of a sponsorship program:

RESOLVED, that it is necessary to create policies governing daily actions of the conduct of officers and of future staff. The CENTRAL COMMITTEE shall empower the officers to decide and draft amongst themselves policies regarding the particulars of their duties and the execution of their powers. Nothing in these policies shall contradict the Bylaws of the SOCIALIST RIFLE ASSOCIATION. All policies drafted, whenever they are drafted, shall be formally approved at the next regular meeting of the CENTRAL COMMITTEE following the completion of the draft.

RESOLVED, that a records retention policy shall be crafted by the officers and formally submitted to the membership and the CENTRAL COMMITTEE by the Secretary. This policy shall meet all applicable legal requirements placed upon the organization in regards to records retention and shall respect member privacy and security of their personally identifiable information. This policy may be published immediately after the full consent of the officers approves the draft, subject to later review by the CENTRAL COMMITTEE.

RESOLVED, that the SOCIALIST RIFLE ASSOCIATION INC. shall begin the process of accepting applications from members in good standing for the SRA Instructor Sponsorship Program. This program shall sponsor individuals to become instructors in the fields of firearm safety and operation, first aid, disaster relief, agriculture, and any other fields applicable under the mission statement of community defense. The CENTRAL COMMITTEE empowers the officers of this organization to create policies, review applicants, and administer this program with the oversight of the CENTRAL COMMITTEE.

RESOLVED, that any individual who receives sponsorship for any instructor program, and successfully completes their sponsorship, shall guarantee their services to the organization on a contract basis for a reasonable time period as determined by the officers. The exact contract and stipulations of of sponsorship shall be determined in consultation with any applicable legal authority and/or legal counsel.

RESOLVED, that the officers or any person they select as their representative may interview any applicant for sponsorship, but that the final authority to select individuals for sponsorship shall be retained by the CENTRAL COMMITTEE.

RESOLVED, that in keeping with its mission as an education and advocacy organization for the working class, the SOCIALIST RIFLE ASSOCIATION shall ensure that any classes taught under its banner by sponsored instructors shall be available to both members in good standing as well as the general public, subject to all applicable laws and regulations concerning any particular field of instruction.

RESOLVED, that the CENTRAL COMMITTEE shall provide reimbursement to Jordan Billings of the CENTRAL COMMITTEE to obtain instructor certification through the United States Conceal Carry Association to provide insights into the process and ensure a smooth process for any selected applicants for the sponsorship program in this field. This reimbursement shall be used entirely for the purposes of obtaining this certification, and receipts shall be provided to that effect. Upon obtaining this certification, Mr. Billings shall assist the officers in ensuring the smooth operation of the program and shall provide instruction under the banner of the SOCIALIST RIFLE ASSOCIATION to members in good standing and the general public as demand allows for.

FURTHER RESOLVED, that the CENTRAL COMMITTEE shall review this program on a quarterly basis and shall provide amendments to this resolution as needed to account for unforeseen or entirely new circumstances.
