

A Resolution to Put to Referendum a Revision of the Bylaws

RECOGNIZED, that the extraordinary growth of the SOCIALIST RIFLE ASSOCIATION has meant the previous mechanisms of the Bylaws are inadequate to deal with the increased needs of the Organization.

RECOGNIZED, that the stated internal goal at the commencement of the SOCIALIST RIFLE ASSOCIATION was to ensure greater chapter control and participation in the National mechanisms of the Organization.

RECOGNIZED, that the proposed Bylaws are the result of significant input and advice of the Chapter Organizers and the National Organizers of the SOCIALIST RIFLE ASSOCIATION.

RECOGNIZED, that the passage of these proposed Bylaws shall require not less than 60% approval in general referendum.

FURTHER RECOGNIZED, that the enactment of these proposed Bylaws shall require significant work from current and future staff members, and that the Organization must ensure sufficient funds to enact these changes.

RESOLVED, that the Bylaws attached to this Resolution shall be put forward to general referendum of the Membership for consideration. Such referendum shall take place from April 30th 12:00PM Central Time, to May 3rd 12:00PM Central Time. Eligible voters shall be all members in good standing at April 29th 11:59PM Central Time.

RESOLVED, that if approved, the Bylaws shall take full effect by June 1st, 2020, and its Continuity Article shall be in full force upon approval by the membership.

RESOLVED, that the Bylaws attached may be revised for any typographical errors found in the interim prior to submission to the membership, but the content and meaning of the Bylaws shall not be altered.

RESOLVED, that in the event of the passage of these proposed Bylaws, the Central Committee shall follow its provisions to empower the Officers and succeeding Administration to take all measures, actions, and procedures necessary to ensure the successful enactment of the Bylaws, to include but not limited to the set up and implementation of any technologies necessary to complete the enactment and enforcement of the Bylaws.

RESOLVED, that the Officers shall select a five-member Electoral Committee to supervise the referendum no later than one week prior to the start of the referendum.

RESOLVED, that members of the CENTRAL COMMITTEE, national Organizers, and chapter

Organizers shall be permitted to express their support or opposition to these bylaws in their professional capacities.


FURTHER RESOLVED, that the Officers may prepare educational material on these Bylaws for disbursement amongst the membership and the Organizers.
