Revolver Basics

What's a Revolver?

Broadly speaking, a revolver is a firearm with a rotating cylinder that holds ammunition, designed to be fired with one hand. There are exceptions, but this definition covers the vast majority of revolvers. There are thousands of models and types of revolvers, in many shapes and sizes, but almost all of them share a common set of features and layout.

Why carry a revolver?

Revolvers are a common firearm carried for self defense outside the home, and are also a frequent choice for recreational and competitive shooters. With proper training and practice, a revolver vastly increases your capacity to defend yourself or others in life-or-death situations, while being simple to operate and maintain, and small and light enough to be carried concealed in a manner that won't alarm those around you. Recreational shooters may enjoy the wide variety of choices available and the reduced size. weight, and cost of revolver shooting compared to a rifle or shotgun. Hikers and campers may find revolvers and their relatively high powered rounds useful when spending time in bear country.



Revolver Components

Not all revolvers will have all of the components pictured here; some will not have a hammer, and single action revolvers will have a loading gate instead of a cylinder release

- Barrel: The tube through which the bullet moves, usually with rifling (spiral grooves)
- Front/Rear Sight: Used to acquire target and aim the revolver
- Hammer: Falls forward to hit the firing pin when the trigger is squeezed
- Grip: Revolver is held here
- Cylinder Release: Used to flip the cylinder out for inspection and reloading

- Trigger Guard: Prevents accidentally squeezing the trigger
- Trigger: Fires the revolver
- Ejector Rod: Used to eject spent cases from the cylinder when open
- Muzzle: Bullet fires from here
